# TREASURER'S REPORT

Treasurer's Report for August 14, 2023. The cash position remains very strong, at \$331,000+. May through July were all record months for overnight use fees. Insurance costs continue to increase.

My overall update is that (1) we can spend at least another \$100,000 on special projects for the Inn during the remainder of the year, and maybe more and (2) we are heading into not just a statewide, but a national crisis, on wildfire risk. Insurers, as you know, are leaving the state, premiums are skyrocketing, and as we see from the parallels between Lahaina and Paradise, the risks are spreading.

## EXECUTIVE DIRECTOR'S REPORT

Past month -many day-to-day inn operational things. Water supply. Tank doesn't fill. MMWD responsive. Clean pipes, etc Stainless steel tank would help. Bonnie has been really available to help. On going issue.

Generator has been also a challenge to manage. PCB drained it. Continuing education with Innkeepers. New generator due September.

Revised Policy For Advanced Whole Inn Bookings to Support Capital Campaign

- Allow four corporate offsite per year booked more than 3 months and up to 3 years in advance
- Corporate offsites would be for up to two consecutive nights mid-week (Monday, Tuesday, Wednesday or Thursday nights).
- We propose that on the website we articulate that we are launching a Capital Campaign to support the long term structural integrity and fire prevention of the Inn to ensure its longevity for generations to come, and that we will be considering applications to rent the Inn for corporate uses as described above. Applicants will be asked to describe the nature of their event, how they would use the Inn, agree to the conditions we describe, and state a proposed tax deductible donation to the Capital Campaign in addition to the whole inn booking fee of \$1400.

- A committee will be formed to consider applications on a rolling basis, with guidance from the BoD regarding minimum suggested donations and accommodation requests.
- Marketing materials will be prepared that can be shared with corporations who might consider renting the inn and contributing to the capital campaign.

Discussion surrounded around estimated costs and total # of attendees including hours of event, noise control etc. Can the board approve weddings or does the entire membership need to approve? Changes to bylaws require all member vote at member meeting. Should board limit weddings to enhance corporate events?

Discussed a 2 year pilot to raise money....board agrees on corporate events....undecided on weddings.

Motion: To amend WPIA policy to allow corporate events 4 a year in order to raise funds for the capital repairs.
